#### **SECTION ONE: EXECUTIVE SUMMARY**

#### **Submission Results**

#### As of the CASE submission deadline date, January 31, 2016

- 48 chapters out of 53 active chapters (91 percent) completed the CASE submission process.
- 24 chapters (50 percent) met 100 percent of all 6 affiliation requirements.
- 24 chapters (50 percent) did not meet 100 percent of all the affiliation requirements.
- Five (5) chapters (6 percent) did not submit any information.

#### **Achievement Data**

The 48 submitting chapters self-evaluated their percentage of achievement of the 6 affiliation requirements.

#### What does the CASE data tell us?

Based on the collected CASE survey data, two of the CASE requirements with the lowest percentage of achievement are in professional development opportunities being made to members and attendance during the Chapter Chairs calls. In 2016, ACRP global intends to make strides to offer more education which can be repurposed locally and the Chapter Advisory Group will examine the need and frequency of continuing the Chapter Chairs conference calls.




