### **CHAPTER EVENT MARKETING & COMMUNICATIONS GUIDELINES**

To assist with managing upcoming chapter events, guidelines have been created to help you managing your event marketing and communications. This updated process was announced in April and now a simplified document is available to help you manage your marketing efforts through ACRP. Remember, your chapter may email its local chapter members as often as you'd like. Chapters are encouraged to email local chapter members about upcoming chapter events, local issues impacting clinical research and any other information on programs and services offered locally.

## CHAPTER AFFILIATION STANDARDS & EXPECTATIONS (THE NEW CHAPTER ANNUAL REPORT)

The ACRP Chapter Affiliation Standards & Expectations (CASE) are a set of performance guidelines designed to help chapters deliver consistent benefits to members. The CASE submission itself (which replaces the previous annual report) consists of two parts:

- Part 1: Annual Update Focusing on the chapter's demographic information.
- Part 2: CASE Survey A self-reporting assessment evaluating the chapter's achievements of the chapter affiliation requirements.

The 2016 CASE submission reports on chapter's activities during the 2015 calendar year. The deadline for submitting the online CASE survey is January 31, 2016. To qualify for the \$500 chapter bonus, chapters must complete the online submission form by this date and the following documents must be attached: 1) 2016 Chapter Board Roster (using the "2016 Chapter Board Roster Template" spreadsheet), 2) 2016 Strategic Plan, and 3) year-end financial results for the period 1/1/2015 – 12/31/2015. *Remember, a signed copy of the new Chapter Affiliation Agreements are also due by January 31, 2016.*
