- **ACRP Certification Exam Prep Course & Train-the-Trainer Session; Friday, April 28** The newly-revised ACRP Certification Exam Preparation Course provides eligible candidates guidance on how to prepare for the ACRP certification exams -- CCRA(R), CCRC(R) and CPI(R). Familiarize yourself with the exam format, gain valuable strategies for preparing for an ACRP exam, tackle sample exam questions, and conduct a personal

gap analysis to ensure you are fully primed to earn your ACRP certification. This portion of the workshop -- Part I -- will run from 7:30 am - 3:00 pm. and will be immediately followed by Part II, a two-hour, train-the-trainer session open ONLY to ACRP Chapter members who seek to become trainers of this course through their chapters. Prospective trainers must participate in Part I of the workshop. Individuals who do NOT wish to become trainers cannot participate in Part II.

Prospective trainers must be pre-qualified to sit for the train-the-trainer segment of the program and are not required to pay the \$225 fee for Part I. Pre-qualification requires indicating your interest in becoming a trainer and emailing your CV to avalleshall@acrpnet.org no later than Friday, April 7.

Mandatory IRS Filing Requirements Deadline May 15

In 1984, ACRP received a [group exemption letter](#) (Group) from the IRS. This letter allows subordinate organizations (chapters) to be granted 501(c)(3) status by virtue of their participation in the Group, thereby avoiding the necessity of individually filing for exemptions. While a group tax exemption number decreases the amount of paperwork required, all chapters must still obtain a separate Employer Identification Number (EIN) and [annually file](#) Form 990 or Form 990N with the IRS. For most chapters this will be May 15, 2017, for the 2016 tax year.

Bring Item Writing Training to Your Chapter!

The NY Metro Chapter was selected for the inaugural in-person training of the Item Writer workshop. It was held on September 24, 2016. The workshop was coordinated by ACRP and facilitated by ACRP's Test Development Partner, Prometric. The event was an interactive and engaging workshop, where members had the opportunity to learn how to write exam questions (also known as "items") as a volunteer subject matter expert. Those who participated felt it was a great way to learn about writing the exam questions, as well as keep abreast of the ICH GCP. As an added bonus, continuing education points were offered toward maintaining your ACRP Certification.

Once trained, participants were invited to join the community of 100+ writer who contribute content for the ACRP Certification Exams while staying sharp on GCPs. This is also an opportunity for members to give back to the clinical research community while earning continuing education points toward your ACRP Certification.

ACRP is seeking additional chapters to host Item Writing training in their area. Chapters will sponsor meeting facilities, breakfast, and lunch.
